## Experience

### **ISIX LLP v. Boomi LP & Dell Inc.**

Defended Boomi and Dell in the Western District of Texas on a patent case related to software integration technology.

### **Profectus Technologies v. Google LLC**

Represented Google LLC in its complete defense verdict from a Texas federal jury in the Western District of Texas in a case alleging that Google's Nest Hub and Nest Hub Max devices infringed a patent asserted by Profectus Technologies.
